#### **VIII. Mental Health Grant**

##### Discussion:

Mr. Saccu discussed the mental health grant. It is \$20,000 over two years. 10th year since starting youth bureau. The school social worker contacted Mr. Saccu last quarter and said there was an uprising in calls to 211, many with self-harm behavior and suicide ideology.

Conditions of the grant are that all staff be trained in QPR - Question, Persuade, Refer; SOS - Signs of Suicide (through video training for both the staff and students to recognize mental health signs), Columbia Lighthouse Project Screening Process and Gizmo's Pawsome - a program of books for younger students

Letter from Mr. Saccu forwarded to the Board:

##### *“Youth Bureau: Re: Mental Health Grant Award*

*As most of you already know toward the end of last school year and over the summer I applied for a two year 20,000.00 mental health and suicide prevention grant co-directed by DMHAS, DCF and the Department of Public Health. This grant is also coordinated by the Network of Care for School Systems, CT Suicide Advisory Board and CT United Way. Dr. Conway had approved me to apply for this grant and I am pleased to announce that Derby is one of only 20 recipients in the State to receive this award. During the latter part of last school year a number of our social workers expressed a need for more consistency in addressing the mental health needs in our district both from a crisis response and prevention standpoint. We were able to start some programs for staff and students at the Brandley School with the help of Katelyn taking the initiative and also provide some training for the Middle School staff. At that point our community prevention mental health partners from BHCare (Alliance for Prevention and Wellness) suggested I apply for this grant. Once the awards were announced a meeting of the Grantees was held in Cromwell. On September 13 Lauren Carbone attended that symposium with myself and Lorrie McFarland from BHCare to review the conditions of this grant. This was a very worthwhile and helpful part of the process in helping us to implement the activities of the grant award. On October 25 I will be making a presentation to the BOE and would like to have a meeting prior with the stakeholders in the district to become familiar with the components of this grant and start laying out some timelines as we move forward. Laurent Carbone will be reaching out to come up with some possible dates and location of this meeting. This is a pilot program for the State and a great opportunity for our district to be seen as a leader in mental health awareness, crisis intervention and suicide prevention both in schools and our community. The Youth Bureau and our partners at BHCare are excited to work with our schools and staff during the next two years to more effectively server or students, families and community concerning such an important topic as mental health.”*

Mr. Izzo thanked Mr. Saccu for the tireless work he does. He's a gentleman and an asset to the community.

In calculating the Salutatorian for the graduating class, the second highest weighted GPA after (7) semesters will be the Salutatorian. In the event that a three (3) year graduation plan student has the same or higher weighted GPA as the four (4) year graduation plan student, the students will be classified as Co-Salutatorians. In calculating the class rank for 3 through 10 for the graduating class, the rank for 3 through 10 weighted GPA after (7) semesters will be the ranking order. In the event that a three (3) year graduation plan student has the same or higher weighted GPA as the four (4) year graduation plan student, the students will be classified as Co-Ranked.
